

VACCINATIONS DO NOT PROTECT

People have been conditioned to believe that vaccines build up antibodies which protect the vaccinated from diseases. This is a misleading claim and has no foundation in fact. Sales propaganda floods the advertising media and many glowing promises are made for vaccinations, but absolutely *no real proof* or evidence has ever been given to support any claim for the value of vaccines. On the other hand, there is substantial proof from scientific sources, court cases and medical reports to support the claims that *all* vaccines are dangerous—even deadly, and *never* beneficial, except in making money for the vaccine promoters. In spite of these obvious facts, many people still want to believe the doctors, and line up and get their bloodstreams shot full of vaccinal poisons.
